giving vulnerable groups in Southern countries better access to adequate water and sanitation

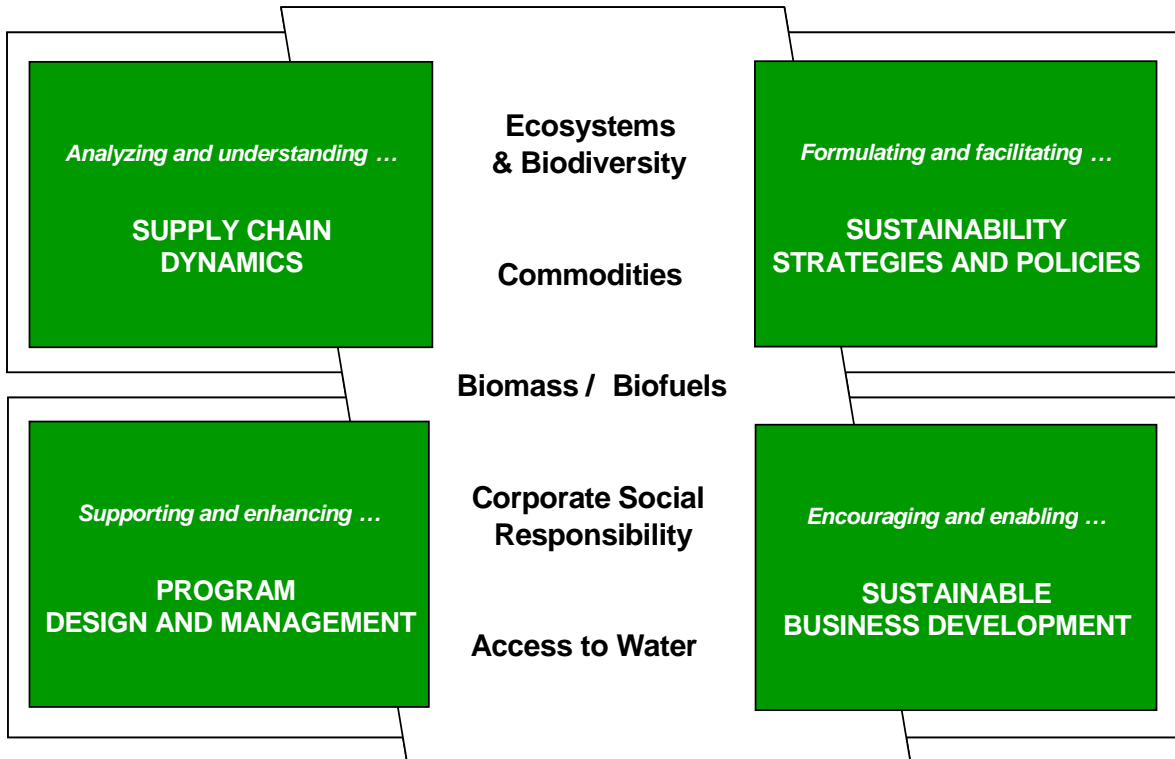
Organisation
