

## Whistle Blower Policy Statement

Date: 4 March 2016

Aidenvironment requires directors, officers and employees to observe high standards of business and personal ethics in the conduct of their duties and responsibilities. As employees and representatives of Aidenvironment, we must practice honesty and integrity in fulfilling our responsibilities and comply with all applicable laws and regulations.

### Article I. Reporting Responsibility

This Whistleblower Policy is intended to encourage and enable employees and others to raise serious concerns internally so that Aidenvironment can address and correct inappropriate conduct and actions. It is the responsibility of all board members, officers, employees and affiliates to report concerns about violations of Aidenvironment's code of conduct or suspected violations of law or regulations that govern Aidenvironment's operations.

### Article II. No Retaliation

It is contrary to the values of Aidenvironment for anyone to retaliate against any board member, officer, employee or affiliate who in good faith reports an ethics violation, or a suspected violation of law, such as a complaint of discrimination, or suspected fraud, or suspected violation of any regulation governing the operations of Aidenvironment. An employee who retaliates against someone who has reported a violation in good faith is subject to discipline up to and including termination of employment.

### Article III. Reporting Procedure

Aidenvironment has an open door policy and suggests that employees share their questions, concerns, suggestions or complaints with their supervisor. If you are not comfortable speaking with your supervisor or you are not satisfied with your supervisor's response, you are encouraged to speak with the Executive Director, or a member of the Board of Directors. Supervisors and managers are required to report complaints or concerns about suspected ethical and legal violations in writing to Aidenvironment's Compliance Officer, who has the responsibility to investigate all reported complaints. Employees with concerns or complaints may also submit their concerns in writing directly to their supervisor or the Executive Director or the organization's Compliance Officer.

### Article IV. Compliance Officer

Aidenvironment's Compliance Officer is responsible for ensuring that all complaints about unethical or illegal conduct are investigated and resolved. The Compliance Officer will advise the Executive Director of all complaints and their resolution and will report at least annually to the head of the Business Support Unit (BSU) on compliance activity relating to accounting or alleged financial improprieties.

**Article V. Accounting and Auditing Matters**

Aidenvironments Compliance Officer shall immediately notify the head of the BSU of any concerns or complaint regarding corporate accounting practices, internal controls or auditing and work with the head of the BSU until the matter is resolved.

**Article VI. Acting in Good Faith**

Anyone filing a written complaint concerning a violation or suspected violation must be acting in good faith and have reasonable grounds for believing the information disclosed indicates a violation. Any allegations that prove not to be substantiated and which prove to have been made maliciously or knowingly to be false will be viewed as a serious disciplinary offense.

**Article VII. Confidentiality**

Violations or suspected violations may be submitted on a confidential basis by the complainant. Reports of violations or suspected violations will be kept confidential to the extent possible, consistent with the need to conduct an adequate investigation.

**Article VIII. Handling of Reported Violations**

Aidenvironment's Compliance Officer will notify the person who submitted a complaint and acknowledge receipt of the reported violation or suspected violation. All reports will be promptly investigated and appropriate corrective action will be taken if warranted by the investigation.
